- # Crude oil dropped as disappointing jobs data from the United States cast doubt about the strength of economic growth.
- # Copper settled flat after release of lower-than-expected U.S. jobs data amid growing supplies.
- # Chana prices dropped on sluggish demand in spot markets and on hopes of bumper production of the winter-sown crop.
- # Mentha oil prices ended with losses due to fall in demand in the spot market.
- # Turmeric prices dropped on hopes of higher production due to good rainfall in key growing areas.
- # Naturalgas dropped after weather-forecasting models called for below-normal temperatures to trek across the U.S. next week.
